

Terms of Use

Current as of 17/02/2018

Please read these terms carefully before using the services offered by AIRSTREAM COMPONENTS PTY LTD. ("AIRSTREAM"). By using the website izone.com.au, air-stream.com.au, Airstream Worldwide, iZone World Wide or other features, services, products, Apps or applications offered by AIRSTREAM (collectively, the "Service"), you (hereafter "User" or "you") agree to be bound by these terms of use (the "Terms").

If you don't agree with these new Terms, you are free to reject them; unfortunately, that means you will no longer be able to use the Service. If you use the Service in any way after a change to the Terms is effective, that means you agree to all of the changes. Except for changes by us as described here, no other amendment or modification of these Terms will be effective unless in writing and signed by both you and us.

The individual who accepts these terms and conditions, must be of a legal age to form a binding contract (or if not, you've received your parent's or guardian's permission to use the Service and gotten your parent or guardian to agree to these Terms on your behalf).

If you're agreeing to these Terms on behalf of an organization or entity, you represent and warrant that you are authorized to agree to these Terms on that organization or entity's behalf and bind them to these Terms (in which case, the references to "you" and "your" in these Terms, except for in this sentence, refer to that organization or entity). You hereby certify you are legally permitted to use the Service, and take full responsibility for the selection, access, and use of the Service.

These Terms are void where prohibited by law, and the right to access and use the Service is revoked in such jurisdictions.

We are constantly trying to improve our Service, so these Terms may need to change along with the Service. We reserve the right to

change the Terms at any time, but if we do, we will bring it to your attention by placing a notice on izone.com.au website, by sending you an email, and/or by some other means.

1. The Service

What are the basics of using the Service?

You may be required to sign up for an account, and select a password and user name (“Airstream World Wide User ID”). As a condition to using the Service or in order to create certain statements through the Service, you may be required to supply AIRSTREAM with certain registration information, including a valid email address, registration information for mobile phones, other mobile devices, or third-party sites or services you access through AIRSTREAM.

You promise to provide us with accurate, complete, and updated registration information about yourself. You may not (i) select or use as your username a name of another person with the intent to impersonate that person; or (ii) use as your username a name subject to any rights of a person other than you without appropriate authorization; or (iii) use as your username a name that is otherwise offensive, vulgar or obscene. AIRSTREAM reserves the right to refuse registration of, or cancel a username in its discretion. You shall not use another user's account or any other person's registration information for the Service, any other mobile phones or other mobile devices, or any third-party services you access through the Service, without that person's permission.

Your right to use the Service continues until it is terminated by either party. You may terminate by discontinuing use of the Service. AIRSTREAM may terminate at any time for any reason. Your use terminates automatically if (i) you violate any term of these Terms, (ii) AIRSTREAM publicly posts a written notice of termination on the Service, (iii) AIRSTREAM sends a written notice of termination to you, or (iv) AIRSTREAM ceases providing access to the Service to you.

AIRSTREAM will use reasonable efforts to ensure that the Service is available twenty-four hours a day, seven days a week. However,

there will be occasions when the Service will be interrupted for maintenance, upgrades and emergency repairs. Indemnity

If any provision of the Terms is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavour to give effect to the parties' intentions as reflected in the provision and the other provisions of such documents remain in full force and effect.

You will be responsible for paying, withholding, filing, and reporting all taxes, duties, and other governmental assessments associated with your activity in connection with the Service, provided that AIRSTREAM may, in its sole discretion, do any of the foregoing on your behalf or for itself as it sees fit.

You may not assign, delegate or transfer these Terms or your rights or obligations hereunder, or your Service account, in any way (by operation of law or otherwise) without AIRSTREAM's prior written consent. These Terms are governed by and will be construed under the laws of the State of Western Australia, without regard to the conflicts of laws' provisions thereof. Any dispute arising from or relating to the

subject matter of these Terms shall be finally settled in Perth, Western Australia, in English. You agree that in all instances any dispute shall be resolved by Arbitration and Mediation by a commercial arbitrator with substantial experience in resolving intellectual property and commercial contract disputes, who shall be selected by the West Australian Court. Notwithstanding the foregoing obligation to arbitrate disputes, each party shall have the right to pursue injunctive or other equitable relief at any time, from any court of competent jurisdiction. For all purposes of this Agreement, the parties consent to exclusive jurisdiction and venue in the state or federal courts located in, respectively, Perth Western Australia. **Any arbitration under these Terms (including any against officers, directors, and employees of AIRSTREAM) will take place on an individual basis: class arbitrations and class actions are not permitted. YOU UNDERSTAND AND AGREE THAT BY ENTERING INTO THESE TERMS, YOU AND AIRSTREAM ARE EACH WAIVING THE RIGHT TO TRIAL BY JURY OR TO PARTICIPATE IN A CLASS ACTION.**

AIRSTREAM's failure to exercise or enforce any right or provision of these Terms shall not constitute a waiver of such right or provision. Any notice to AIRSTREAM that is required or permitted by these Terms shall be in writing and shall be deemed effective upon receipt, when sent by confirmed e-mail to sales@air-stream.com.au or when delivered by nationally recognized overnight courier or mailed by first class, registered or certified mail, postage prepaid, to AIRSTREAM PTY LTD, 9 Geelong Court, Bibra Lake, Western Australia, 6163, Attention: The Directors.
